







# HISTORY OF THE COLLEGE

The need of a degree college at Nilbagan had been felt right since the early 1980s. A galaxy of education-lovers went even to the extent of collecting funds for the noble purpose. It is, however, a matter of regret that despite their great dedicative efforts, they fell short of their well-meaning goal. After long fifteen years, the zeal resurfaced with renewed verve and at the bold initiative a group of far-sighted and progressive academicians, intellectuals and prominent social activities of the locality, a degree college at Nilbagan saw the light of the day in the year 1995. The classes were initiated with a small number of students in the campus of Nilbagan Higher Secondary School, which is presently acclaimed as Model Higher Secondary School. But for the help and support of the member of the Nilbagan Higher Secondary School, the college would not have been what it is today. As the years passed, a great numbers of students were admitted and new teachers came up to render their selfless service.



Even as the Managing Committee continued with their untiring efforts, the college was passing through a difficult times and the committee was in acute need of a philanthropist who could help the college march steadily along the path of progress.

In the meantime, as luck would have it, Mr. Sirajuddin Ajmal, a great visionary was elected M.L.A. of Jamunamukh Assembly Constituency. In the year 2006, the Committee, approached the newly elected M.L.A. to steer the college in the capacity of his being the President in the noble of the society. Mr. Ajmal, who is known for his love of education and generosity, responded positively to the call of the people. Inspired by the able leadership of Mr. Sirajuddin Ajmal, a large meeting of the local people was held in 2008. The meeting formed a new Management Body for the College. In that very meeting, it was unanimously resolved that the college be placed under the aegis of Ajmal Family to get over its besetting financial crisis, and also be renamed after any of the members of the Ajmal family. Mr. Sirajuddin Ajmal, who graced the Chair in the meeting, was highly impressed by the impassioned appeals of the broad mass of people and conceded to their demands. Mr. Sirajuddin Ajmal took no time to declare his willingness to contribute a sum of Rupees One lakh (Rs. 1,00,000/-) as token of the first gift to the College Funds and promised that the Ajmal Group would take the entire responsibility of elevating the College into a full-fledged Degree College. At the same time, he appealed to the local people to lend him a helping hand in developing the College into an institution of excellence. He also urged the new Management Committee to make arrangements for shifting the college to its own land on the Nilbagan-Murajhar Road, for which he was ready to provide every help.

The college was shifted to its own land under his sole sponsorship on the year 2008. To accommodate not fewer than 300 students, the first makeshift classrooms were housed in a 153 ft. long low- cost R.C.C. posts and G.C.I sheets. The Committee then appointed a permanent Principal and the required teaching and non- teaching staff of the college.

In a meeting of the Extended Executive Body on 29th June, 2008, it was unanimously resolved to rename Nilbagan College as 'Haji Ajmal Ali College, Nilbagan' in recognition of the phenomenal services of Haji Ajmal Ali, the founder of AJMAL Group of Companies. Revered Haji Ajmal Ali, the business icon, is today known across the world more as a 'Charity King' than any other name. He left us for all heavenly abode on 17th February, 2009. May his noble soul rests in eternal peace! As of the year 2009, the College boasts the construction of its Assam- type 4500 sq.ft. building along with another academic block to capacitate not fewer than a thousand students.

At present, the College has well infrastructure and well demarcated boundary wall with natural beauty. Efforts are as on to augment and meet the infrastructural norms set by the UGC. The president of the college, a great visionary, has cherished the dream to impart modern quality education through this institution and to raise it to a centre of excellence with all modern educational avenues. It is in the process of a phase-wise development.

## **ATTENDANCE**

*It is obligatory to attended classes regularly and punctually. Willful absence from the class room lecturers will be treated as a serious breach of school discipline. As a rule each student is required to obtain a minimum of 85% (H.S. classes) attendance of total lectures delivered in each subject in an academic session.*

*A student shall not be eligible to sit for Examination if he/she has not attended a minimum of 85% lectures delivered in each Subject separately. If a student remains absent consecutively for 3 days or more without any prior information, he/she will rejoin the school with application signed by the guardian along with necessary supporting documents if needed.*

*A student failing to attend classes for 15 days at a stretch from the date of commencement of classes shall forfeit his/her seat. List of students failing to attend minimum classes required will be notified by the Principal and will be sent to their Parents/Guardians.*

## **LIBRARY**

*The school maintains a well-stocked library. There are a large number of dailies, weeklies, periodicals and journals in the institution library. Students, teachers and other members of the staff of the school are entitled to become members of the library, some books are kept reserved for campus study only. Students are required to carry the Identity Cards on their persons while using Library/Reading Room.*

## **LIBRARY RULES**

1. One Book once a week may be issued to a student on production of Library Card.
2. Students should carefully examine the Books issued to them before leaving the library counter. If any damage to the book issued is noticed, it should be reported to the Library Incharge immediately. Otherwise, he/she will be responsible for the damage if detected afterwards at the time of return.
3. Any student retaining the book beyond the stipulated time shall pay a fine of Rs. 10.00 per day till the book is returned. However an amount of Rs. 20.00 per day will be charged in case of reference books.
4. No books will be issued to the defaulting student until the fine is paid. A student failing to return book consecutively for 3 times, shall forfeit his/her membership to the library.
5. The books borrowed from the library must be returned 7 days before the commencement of Annual promotional/Test examination; otherwise the result of the students will be kept withheld.

## ADMISSION PROCEDURE

- Candidate will be selected on merit basis. The list of selected candidates will be notified one day before the actual date fixed for admission. Candidates selected for admission have to take admission on payment of requisite fees on the date fixed for interview and admission failing which is authority keeps the right reserved to forfeit claims.
- There is provision for reservation of seats for SC, ST and OBC candidates as per the Government rules.
- Attested copies of the following documents must be attached with the application for Admission. Documents in original shall have to be produced for verification at the time of admission failing which the admission will be rejected.
- All admissions are provisional subject to the approval of Assam Higher Secondary Education Council.

*Apart from the Final Examinations conducted by the AHSEC, the school conducts Unit, Test Weekly Test, Monthly Test, Pre-Final/Annual examinations.*

## **SCHOOL TRANSFER**

*Application to the Principal for Transfer Certificate will have to be accompanied by Clearance of Dues, Library Books.*

## **MIGRATION**

*Students from Boards other than SEBA shall have to produce Migration Certificate at the time of Admission.*

## RULES OF DISCIPLINE

Any of the following acts by a student shall be considered as a major offence against discipline:

1. Habitual unpunctuality
2. Various kinds of immoral and indecent acts
3. Smoking and use of intoxicants
4. Resorting to violence of any kind
5. Disobedience to teachers and school authority
6. Defacing, damaging or devaluing any school property
7. Acts of public nuisance, breach of public peace, communal trouble etc.
8. Ragging
9. Holding any meeting in the school campus without prior written permission from or against the order of the principal
10. Indulging in any strike, picketing, hartal and hunger strike of any kind
11. Any notice framed by the principal from time to time for maintaining discipline in the school. Every student in the school is subject to and must submit to the discipline of the school. A school student shall be liable to disciplinary action which may lead to suspension, transfer or expulsion from the school for violation of any rules of discipline.
12. Use of Mobile Phones by the students inside the school campus is strictly prohibited.
13. Fee once paid will not be refunded back in case any student voluntarily leaves the school after taking admission.
14. It is Compulsory for students to attend all classes regularly. Students with less than 85% attendance in an academic session year will not be allowed to sit for the final exam.



## SPOKEN ENGLISH COURSE

English is widely used language all over the world and skill of communication in English assumes a great deal of significance in our social context. The academic and professional qualifications acquired, the vast general knowledge stored so far would be of little worth as long as one cannot communicate his knowledge, thoughts & ideas in fluent English. Though English is there as one of the subjects in our schools and colleges, the students do not understand and speak nicely because the region prevails on vernacular medium. In addition to that if a student doesn't know English, he will also be unable to understand computer, as in computer learning everything is in English. Therefore, Haji Ajmal Ali Senior Secondary School, Nilbagan has given special preference on English and has provided facility to every student to learn spoken English daily. 
